Who is it for?

This course is designed for newly qualified lawyers and law students aged 20-30. Course content

This legal English course focuses on developing your English skills in a legal setting, and the vocabulary of criminal law, civil law, contract law, and commercial law. Areas of focus include:

- ▶ Spoken fluency – case studies, legal process, negotiations
- ▶ Legal vocabulary – relating to commercial law, contracts, describing legal concepts
- ▶ Grammar development
- ▶ Listening practice and comprehension
- ▶ Communication skills – discussions, negotiations, conflict resolution, dealing with difficult situations
- ▶ Teleconferencing and Spoken communication
- ▶ Contract drafting techniques
- ▶ Networking English – hospitality, travelling, inviting, advising, apologising.
- ▶ Visits to the law courts such as The Royal Courts of Justice or the Old Bailey when possible
